Property Tax Exemption (SCDOR)

Disabled veterans can now obtain a South Carolina Property Tax exemption on real estate from the year in which they became disabled. The exemption was expanded by legislation signed by the governor in March and retroactive to 2022.

Under the new legislation

- A South Carolina military veteran who is totally and permanently disabled may immediately claim a Property Tax exemption on real estate the veteran owns beginning with the year in which the disability occurs.
- The exemption is retroactive to 2022 and is based on the date that the veteran acquires the property.
- Surviving spouses of totally and permanently disabled Veterans, if eligible, can immediately claim the exemption in the same manner as the veteran, regardless of whether the disabled Veteran applied for or claimed the exemption (applicable on a primary residence and up to five (5) adjoining acres).
- The change does not apply to Medal of Honor recipients or former prisoners of war.
- If a Veteran or a surviving spouse owns real estate for less than a year, any other owner not a disabled Veteran or otherwise entitled to an exemption is responsible for the Property Tax for the time they owned the property.

The new law also provides for new benefits involving disabled Veterans' vehicles

- Surviving spouses who move to South Carolina after the totally and permanently disabled Veteran has passed away now qualify for a Property Tax exemption on one vehicle, if eligible.
- Vehicles can qualify if titled to a trustee, but only if the Veteran or the surviving spouse is the income beneficiary of the trust, satisfies all other criteria, and uses the vehicle.
- Vehicles solely in the spouse's name can qualify if...
 - The spouse resides with the disabled Veteran
 - The vehicle is registered at the same address
 - Vehicles will count toward the limit of two vehicles allowed per disabled Veteran.

Income Tax Exemption (SCDOR)

All military retirement pay is exempt from South Carolina Individual Income Tax beginning in tax year 2022, one of many tax breaks offered to veterans and military in South Carolina.

Tax Deductions & Exclusions

- Governor Henry McMaster signed the [Workforce Enhancement and Military Recognition Act](#), which exempts all military retirement pay that is included in South Carolina taxable income from the state's Income Tax, no matter the taxpayer's age.
- Can be claimed by a surviving spouse receiving military retirement income from their deceased spouse.
- Retirees can start, stop or change State Income Tax Withholding (SITW) by using [myPay](#), filling out a [DD Form 2866 Retiree Change of Address/State Tax Withholding Request](#), or sending a written request that includes all of the necessary information.
- If you choose to send a DD Form 2866 or a written request, mail it to: Defense Finance and Accounting Service, U.S. Military Retirement Pay, 8899 E 56th Street, Indianapolis, IN 46249-1200. Do not send either document to the SCDOR.

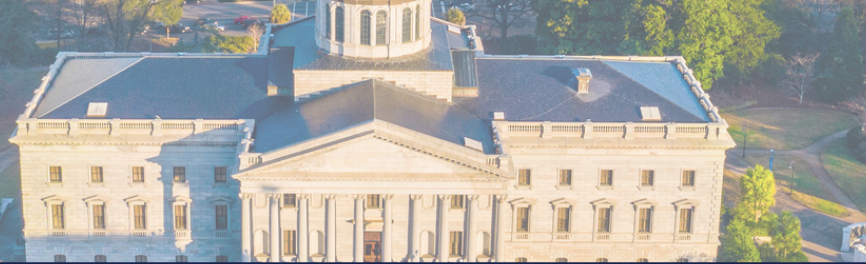
Other Income Tax Exclusions

- Any federal tax-exempt pension or compensation provided by the U.S. Department of Veterans Affairs
- Combat pay and certain benefits not included in federal taxable income
- Retirement income paid by the U.S. government for service in the Reserves or National Guard
- Income received for service in the National Guard or the Reserves for customary annual training, weekend drills, and other inactive duty training is generally exempt
- Service pay for non-resident military personnel on active duty in South Carolina who are legal residents of other states

Hunting and Fishing Licenses (SCDNR)



Provides for free hunting/fishing license to disabled Veterans. License must be applied for directly from SC Department of Natural Resources showing proof of disability. Licenses must be renewed every three (3) years.

Special License Plates (SCDMV)

Upon establishing proof of eligibility to entitlement, the S.C. Department of Public Safety, 803.737.4000, may issue special motor vehicle license plates to the following:

State Park Benefit for Totally Disabled Persons (SCPRT)

Provides that any South Carolina resident who is a permanently and totally disabled Veteran may enter any state park at a reduced rate upon presentation of supporting disability documentation. The veteran may also apply for a reduced fee "Palmetto Passport". Certain services may require an additional fee.

Palmetto Pathfinder Program (SCDVA)

The Palmetto Pathfinder Program is the State Veteran mentorship program designed to connect transitioning servicemembers from the military and Veterans in the community with a mentor. Pathfinders help transitioning servicemembers navigate the process when leaving the military and help Veterans in their community connect with resources based on the Veterans request for assistance.

M.J. Dolly Cooper Veterans' Cemetery (SCDVA)

The M.J. "Dolly" Cooper Veterans Cemetery, located on 57 acres, opened in December 2007. As of 30 June 2017, 2,722 Veterans, spouses and dependents, have been buried with another 5,718 registered (pre-certified) with the cemetery for burials in the future.

"Pre-certified" means the cemetery has determined eligibility after receiving, reviewing and keeping on file copies of a veteran's DD-214 or discharge document and marriage certificate so when a need arises, scheduling a burial can be done without delay.

SC Tuition & Wavier Assistance (SCDVA)

Provides a tuition waiver for qualified children of certain military Veterans applying to or enrolled in a South Carolina state supported college, university or post high school technical education school; or acceptance into a dual enrollment/early college credit program prior to graduating high school. Qualifying Veterans and students must meet certain residency requirements.

- **Do not mail or fax paper applications.**
- **Do not submit duplicate applications; doing so hinders processing time.**
- Once applications are submitted, applicants will receive an automated response immediately. Please note, applicants will not receive status updates during processing.
- Approval letters will be emailed (to institution of choice), and denial letters will be sent to students electronically via email.
- Processing times may vary based on the volume of applications received.

Military Spouse Licensure



In an effort to assist military spouses who hold an active professional or occupational license in another state who are relocating to South Carolina, our state allows for an expedited licensure process as long as their license is in good standing.

The South Carolina Department of Labor, Licensing, and Regulation (LLR) prioritizes military spouse applications to ensure they are processed as quickly as possible.

If you are interested in applying for licensure, please complete the [Military Spouse Expedited Licensure Request Form](#), and a member of LLR will contact you directly to provide you with guidance on the additional information the state needs to grant licensure.

If you have questions that you would like answered before you complete the expedited licensure form, then please email those questions to militaryspouseinfo@llr.sc.gov

NOTE: Please be prepared to provide your military orders to South Carolina, your marriage license, and verification of licensure in every jurisdiction that issued you a license (active or not).

Pre-Discharge Claims Assistance

If you have a service-connected condition, you can file a claim for disability benefits 180 to 90 days before you leave the military. This may help speed up the claim decision process so you can get your benefits sooner. To find out how to file a claim through the Benefits Delivery at Discharge (BDD) program. Federal Employment

Veterans seeking employment within the federal government can access a range of opportunities and programs designed to assist them in navigating the hiring process and obtaining jobs that align with their skills and experience.

The primary platform for applying to federal jobs is [USAJOBS.gov](https://www.usajobs.gov). Veterans can use this platform to search for positions, create profiles, and apply for jobs.

The site allows Veterans to:

- Self-identify as a Veteran
- Search for Veteran-specific opportunities
- Access to federal resume guides

Disability Compensation –SCDVA Website

Disability compensation is a monthly benefit paid to veterans for any injury, condition, or illness that started in or was exacerbated by active service in the military. This benefit is tax free and also can be paid to veterans disabled from treatment in a USDVA healthcare facility. Veterans may be eligible for disability compensation if they have a service-connected disability, often referred to as "S/C", and were discharged under other than dishonorable conditions. A service-connected disability does not have to be a combat injury; any injury or illness suffered or aggravated while in uniform can be considered. GI Bill – USDVA

GI Bill benefits help you pay for school and cover expenses while you're training for a job. Since 1944, the GI Bill has helped qualifying Veterans and their family members get money to cover all or some of the costs for school or training. If you applied for and were awarded Post-9/11 GI Bill education benefits, your GI Bill Statement of Benefits will show you how much of your benefits you've used and how much you have left to use. VA Grant-Funded Cemeteries in South Carolina

Eligibility is similar to Department of Veterans Affairs (VA) national cemeteries, but may include residency requirements. Even though they may have been established or improved with Government funds through VA's Veterans Cemetery Grants Program, state, territory and tribal veterans cemeteries are operated and maintained by the states, territories or tribes. BASIC ELIGIBILITY

- The Veteran must have an honorable discharge from the Armed Forces and provide a copy of the DD-214 or Military Discharge showing character of discharge and dates of active service.
- The Veteran must have been a resident of South Carolina:
 - when the Veteran entered the Armed Forces; or
 - when the Veteran or eligible family member, died; or
 - for five years, unless for a reason that the South Carolina Division of Veterans' Affairs finds compelling, and South Carolina Division of Veterans' Affairs waives the time period.

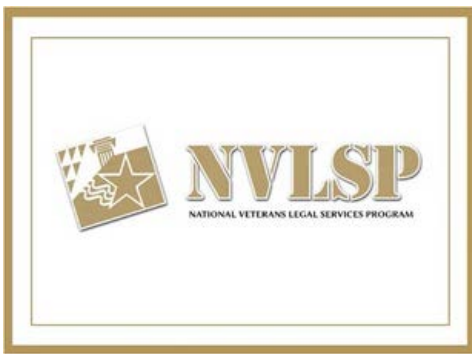
Legal Assistance

National Veterans Legal Services Program (NVLSP)

The National Veterans Legal Services Program (NVLSP) is an independent nonprofit organization that has worked since 1981 to ensure that the government delivers to our nation's Veterans and active-duty personnel the benefits to which they are entitled because of disabilities resulting from their military service to our country.

NVLSP recruits, trains, and assists thousands of lawyers and non-lawyer advocates who provide free legal representation to veterans and active-duty military personnel. NVLSP's [Veterans Benefits Manual](#), the comprehensive treatise on Veterans' law, empowers Veterans, current service members, their families, and their advocates to obtain the benefits they're entitled to by clearly outlining their rights under the law. NVLSP provides free representation through its [Lawyers Serving Warriors®](#) (LSW) pro bono program. LSW offers free legal help to veterans and service members on a number of benefits issues; cases are placed with volunteer attorneys from law firms and corporate legal departments nationwide.

Lawyers Serving Warriors® (LSW) Program

NVLSP's Lawyers Serving Warriors® program offers pro bono (that is, free) legal help with disability issues to veterans from all eras. Our current pro bono initiatives are to assist veterans with the following types of disability claims:

- Assistance with Discharge Upgrades for Veterans from All Eras
- Applications for Combat Related Special Compensation (CRSC)
- Applications to Boards for Correction of Military Records (BCMRs) for veterans who were wrongfully discharged for personality disorder or adjustment disorder
- Applications to Boards for Correction of Military Records (BCMRs) for veterans who wish to obtain disability retirement
- Assistance with VA claims for Mental Health and/or Physical Condition(s) including PTSD due to military sexual trauma (MST)
- Applications to the Physical Disability Board of Review (PDBR) for an increase in the military disability rating to attain a permanent disability retirement
- Representation to service members being processed through the Integrated Disability Evaluation System (IDES)

Basic Eligibility

A person who served in the active military, naval, or air service and who was discharged or released under conditions other than dishonorable may qualify for VA healthcare benefits. Reservists and National Guard members may also qualify for VA healthcare benefits if they were called to active duty (other than for training only) by a federal order and completed the full period for which they were called or ordered to active duty may be eligible for VA healthcare.

Minimum Duty Requirements

To be eligible, Veterans who enlisted after September 7, 1980, or who entered active duty after October 16, 1981, must have served 24 continuous months or the full period for which they were called to active duty. This minimum-duty requirement may not apply to veterans discharged for hardship, early out or a disability incurred or aggravated in the line of duty.

Certain VA benefits require service during wartime. Under these laws, the VA recognizes the following war periods:

- **WORLD WAR II**
December 7, 1941 through December 31, 1946, inclusive. If the veteran was in service on December 31, 1946, continuous service before July 26, 1947 is considered World War II service.
- **KOREAN WAR**
June 27, 1950 through January 31, 1955, inclusive.
- **VIETNAM WAR**
February 28, 1961 through May 7, 1975, inclusive, in the case of a veteran who served in the Republic of Vietnam during that period. August 5, 1964 through May 7, 1975 is inclusive in all other cases.
- **GULF WAR**
August 2, 1990 through a date to be set by law or Presidential Proclamation.

Enrollment

Note: Enrollment in the VA Healthcare System does not necessarily mean that a Veteran has a service-connected disability.

- To apply, complete VA Form 10-10EZ, Application for Health Benefits. This form can be obtained from any VA healthcare facility or regional benefits office, downloaded at www.va.gov/vaforms, or requested by contacting the Columbia VA Regional Office at (803) 647-2434 or contacting your local County Veterans' Affairs Office.
- Once enrolled, Veterans can receive treatment at a VA healthcare facility anywhere in the country. Veterans enrolled in the VA healthcare system are afforded privacy rights under federal law.

The following four categories of Veterans are not required to enroll, but are urged to do so to permit better planning of health resources:

- Veterans with a service-connected disability of 50 percent or more;
- Veterans seeking care for a disability the military determined was incurred or aggravated in the line of duty, but which VA has not yet rated, within 12 months of discharge;
- Veterans seeking care for a service-connected disability only;
- Veterans seeking registry examinations (Depleted Uranium, Ionizing Radiation, Agent Orange, Gulf War/Operation Iraqi Freedom and Operation Enduring Freedom Veterans).

Note: Eligible Veterans enrolled in VA Health Care can obtain a Veteran Health Identification Card (VHIC) to use to check into VA health care appointments. To obtain your VHIC, contact your nearest VA Medical Center or [apply online](#).

The PACT Act and your VA Benefits

The PACT Act is perhaps the largest health care and benefit expansion in VA history. The full name of the law is The Sergeant First Class (SFC) Heath Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) Act.

The PACT Act will bring these changes:

- Expands and extends eligibility for VA health care for Veterans with toxic exposures and Veterans of the Vietnam, Gulf War, and post-9/11 eras
- Adds 20+ more presumptive conditions for burn pits, Agent Orange, and other toxic exposures
- Adds more presumptive-exposure locations for Agent Orange and radiation
- Requires VA to provide a toxic exposure screening to every Veteran enrolled in VA health care
- Helps us improve research, staff education, and treatment related to toxic exposures
- If you're a Veteran or survivor, you can file claims now to apply for PACT Act-related benefits.

Eligibility

- You're eligible to enroll now—without needing to apply for disability benefits first—if you meet the basic service and discharge requirements and any of these descriptions are true for you:
- You served in the Vietnam War, the Gulf War, Iraq, Afghanistan, or any other combat zone after 9/11, or
- You deployed in support of the Global War on Terror, or
- You were exposed to toxins or other hazards during military service at home or abroad
- Specific toxins and hazards include burn pits, sand and dust, particulates, oil well or sulfur fires, chemicals, radiation, warfare agents, depleted uranium, herbicides, and other occupational hazards. [Find more military exposure categories on USDVA's Public Health website](#)
- Note: Even if none of these descriptions are true for you, you may still be eligible for VA health care based on your service. [Check the full health care eligibility requirements](#)

Presumptive Conditions for Toxic Exposure

To get a VA disability rating, your disability must connect to your military service. For many health conditions, you need to prove that your service caused your condition.

But for some conditions, we automatically assume (or “presume”) that your service caused your condition. We call these “presumptive conditions.”

We consider a condition presumptive when it's established by law or regulation.

If you have a presumptive condition, you don't need to prove that your service caused the condition. You only need to meet the service requirements for the presumption.



South Carolina Governors Challenge– SCDVA

In September 2021, the South Carolina Department of Veterans' Affairs (SCDVA) assumed responsibilities for the South Carolina Governor's Challenge, which had been previously headed by the South Carolina Department of Mental Health (SCDMH).

[The Substance Abuse and Mental Health Services Administration \(SAMHSA\)](#) has partnered with the [United States Department of Veterans' Affairs \(VA\)](#) to bring the [Governor's Challenge to Prevent Suicide Among Service Members, Veterans, and their Families](#) to states and communities across the Nation.

The VA's National Strategy for Preventing Veteran Suicide provides a framework for integrating and coordinating suicide prevention activities across multiple sectors. The Governor's Challenge advances the principles of the National Strategy by facilitating policy-to-practice implementation plans. These plans will serve as instruments of change, providing a best-practice public health model that demonstrates meaningful results in suicide prevention. The Governor's Challenge is a coalition of Veterans, state agencies/leaders and mental health professionals committed to raising awareness and implementing programs aimed at Veteran suicide prevention.

Veterans' Homelessness & Transition Grant (SCDVA)

The Veterans' Homelessness and Transition Grant was established on October 16, 2023, to provide funding to organizations that serve homeless Veterans or Veterans at imminent risk of being homeless with resources to obtain permanent housing.

- The Veterans Homelessness and Transition Grant Program is funded through an appropriation by the South Carolina General Assembly and managed by the South Carolina Department of Veterans' Affairs (SCDVA).
- Aims to enhance nonprofit organizations and state agencies' housing assistance programs for Veterans.
- The South Carolina Department of Veterans' Affairs will award a grant (\$50K-\$250K) per cycle to nonprofit groups and state governmental agencies that assist eligible South Carolina Veterans with housing assistance, utility or rental assistance, drug addiction treatment and transitional housing programs.

Housing



Home Improvements (USDVA)

This benefit provides medically necessary improvements and structural alterations to Veterans/Service members' primary residence for the following purposes:



U.S. Department
of Veterans Affairs

- Allowing entrance to or exit from the primary residence
- Use of essential lavatory and sanitary facilities (e.g. roll in showers)
- Allowing accessibility to kitchen or bathroom sinks or counters (e.g. lowering counters/sinks)
- Improving entrance paths or driveways in immediate area of the home to facilitate access to the home through construction of permanent ramping
- Improving plumbing or electrical systems made necessary due to installation of home medical equipment

HISA will not pay for:

- Walkways to exterior buildings
- Spa, hot tub, or Jacuzzi
- Exterior decking
- New construction

VA Housing Assistance (USDVA)

Specially Adapted Housing (SCDOR)

- Provides for the exemption of state, county, and municipal taxes on the residence of Veterans who have lost the use of their lower extremities or who have paralysis of one lateral half of the body resulting from injury to the motor centers of the brain.

MCEC Purple Star Schools



[The South Carolina Department of Education](#) provides support to military families in South Carolina by awarding Purple Star designation to schools and school districts that show a significant commitment to supporting military families and students of servicemen and women.

Designated schools/districts will have met specific requirements, targeted training (provided by the Military Child Education Coalition), and implemented programs and resources designed to support the unique situations facing military students and families.

[Military Child Education Coalition \(MCEC\)](#) is the national advocate for Purple Star Schools, a program that supports military-connected children as they relocate to new schools due to a parent's change in duty station.



Military children move every two to three years. The Purple Star School program is designed to help schools respond to the educational and social-emotional challenges military-connected children face during their transition to a new school and keep them on track to be college, workforce, and life-ready. Military-connected refers to children of service members on active duty, and in the National Guard and Reserves.

MCEC is the nation's most complete resource for states seeking to start a Purple Star School program.

In-State Tuition Benefits

SC Tuition Assistance for Certain War Veterans' Children

Provides a tuition waiver for qualified children of certain military Veterans applying to or enrolled in a South Carolina state supported college, university or post high school technical education school; or acceptance into a dual enrollment/early college credit program prior to graduating high school. Qualifying Veterans and students must meet certain residency requirements.

- **Do not mail or fax paper applications.**
- **Do not submit duplicate applications; doing so hinders processing time.**
- Once applications are submitted, applicants will receive an automated response immediately. Please note, applicants will not receive status updates during processing.
- Approval letters will be emailed (to institution of choice), and denial letters will be sent to students electronically via email.
- Processing times may vary based on the volume of applications received.

WHAT IS LOCK IT SC?

Lock It South Carolina is a suicide prevention initiative with the South Carolina Department of Veterans' Affairs and the South Carolina Governor's Challenge Team. The initiative aims to promote safe and responsible care of Lethal Means, including firearms and medication and providing information to address and increase public understanding of Veteran Suicide.

WHAT IS LETHAL MEANS?

Lethal means is an intentional and voluntary practice to increase time and space between an individual and a lethal mean (firearm, medication, asphyxiation device), therefore reducing the risk of intentional harm (suicide, domestic violence) and accidental harm (injury or death).

Increasing the time and distance between someone in a suicide crisis and access to lethal means can reduce suicide risks and save lives.

FRAMING THE CONVERSATION



Having a conversation with a Veteran about firearm safety can be challenging. As someone who likely had some level of firearm training during their military service, the Veteran may not be receptive to talking about best practices for gun storage and security. It can be helpful to frame your conversation around the safety of others — family, friends, or children who may not know how to properly handle a firearm or understand its dangers, which could result in accidental injury or death.

KEY PRINCIPLES



- ✓ Limiting access to lethal means for a person in crisis helps prevent suicide
- ✓ Helping to educate personnel that take a gun lock on why it matters
- ✓ Safe handling and secure storage of lethal means at home is encouraged
- ✓ Proper disposal of unwanted medications and keeping medications away from children

MEDICATION SAFETY



Proper storage of medications and disposal of medications are important to reduce the risks of self-harm and unintentional accidents.

- ✓ Take medication only prescribed to you and only as prescribed
- ✓ Never share medications with others
- ✓ Store all medication in an inaccessible, secure place, or a locked container
- ✓ Keep track of each type and amount of your medications
- ✓ Dispose of unneeded and outdated medications by using your community's medicine drop box
