Please explain how these funds will be used to provide a public benefit:

This request will go to funding a Military Museum, which will consist of two public facilities an exhibit facility and a related storage facility. The facilities will serve to permanently house, preserve, and protect military artifacts and memorabilia tied directly to US history, which includes Sumter's 16,000+ veterans and Shaw Air Force Base. Additionally, Military Commanders at Shaw AFB have expressed that the addition of an inclusive military museum would be a welcome addition to increasing the quality of life for active-duty military members and their families. The museum will be located inside Sumter's Hampton Park Historic District and near our historic Downtown. The museum will encompass an exhibit hall, archival storage areas, curation offices, workshop space for displays, meeting space, and more — all in temperature and humidity-controlled archival-grade facilities. Additionally, ample parking will be designed to allow for tour buses and handicap accessibility. This project includes multiple parcels of land that have recently been purchased and assembled by City, County, and the Sumter County Museum. The project has also received a private donation from the Williams Brice-Edwards Charitable Trust in excess of \$540,000. Local funds are currently being invested for the design and architectural plans for this project, with a planned infusion of an additional \$1,000,000 in the near future.
